




This chart shows the total general purpose revenue New Pacific School Rancho Cordova expects to receive in the coming year from all sources.

Of the \$1,085,516.00 in LCFF Funds, \$106,642.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


