

The text description for the above chart is as follows: The total revenue projected for Twin Rivers Unified School District is \$14,951,282, of which \$13,161,832 is Local Control Funding Formula (LCFF), \$287,751 is other state funds, \$638,798 is local funds, and \$862,901 is federal funds. Of the \$13,161,832 in LCFF Funds, \$1,185,970 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Introduction: Heritage Peak Charter School (HPCS) is authorized by the Twin Rivers Unified School District. The school has been operational for over 15 years. The current enrollment is 1106 students. The school serves TK-12th grades through a variety of home school/independent study models utilizing three resource centers. The school is governed by Pacific Charter Institute's (a non-profit) Board of Directors and is an active member of California Charter Schools Association, Charter School Development Center, and APLUS+ advocacy groups. During the 2014-15 school year, Heritage Peak was awarded a 6-year accreditation by the Western Association of Schools and Colleges (WASC). In October 2019, the Twin Rivers School Board voted unanimously to renew the Charter for another 5 years.

Our significant student demographics consist of 12% Special Education, 19% EL (predominantly Spanish and Russian/Ukrainian speakers), 47% Socio-economically disadvantaged, .09% Foster Youth and 1.4% Homeless groups. The largest groups at HPCS consist of our Hispanic and socio-economically disadvantaged students at 23% and 47% respectively. Consequently, these specific groups are the target of our school-wide learning goals for our Local Control Accountability Plan.

Heritage Peak Charter School continues to focus on decreasing our cohort dropout rates and increasing our graduation rate from 97% to 100%.

Based on a review of performance on state indicators, Heritage Peak Charter School has identified our greatest progress was overall improvement in math, (10 points) as demonstrated by the most recent available CAASPP scores. Reviewing winter to winter assessment

result and can be attributed to increased progressed monitoring through the establishments of PLCs to create actionable steps to support our students.

Heritage Peak Charter School supports the fluidity and adaptability of an independent study program to meet the individual needs of every student. Our school offers students the opportunity to access a pathway to college and career in a manner most beneficial to individual student needs. The school supports all students in becoming competitive 21st century-ready individuals. Our LCAP plan is designed to support all students both academically and social emotionally. All Heritage Peak students, including those in identified significant student groups (12% SPED, 5% African American, 23% Hispanic, 47% Socio-economically disadvantage, and 19% EL/RFEP) will continue to improve proficiency in the Common Core Standards for Mathematics and English Language Arts. All 2nd grade cohort students at HPCS will achieve benchmark status as measured at end-of-year local measures using DIBELS by the 2023-2024 school year and students in cohort grades 3-8 students will show growth over time as measured by NWEA MAP. Additionally, all k-2 grade students will be progress monitored in math using mClass. At Heritage Peak Charter School, we believe that every student can learn.

Engaging Educational Partners

As a school of choice, all educational partners from staff to parents/guardians to community partners are very engaged in the learning that occurs in our school. The development of our LCAP happens throughout the year, and educational partners give feedback in various ways. Due to our positive one-on-one relationships with our families, regular announcements tied to programs/opportunities related to our LCAP were sent via school email and text via SwiftReach and homeroom teachers. In March 2023 we launched our LCAP Academic Support Survey to all statutorily required educational partners as applicable to our school. The survey included questions about students' academic needs and the effectiveness of the school's support. In May 2023 a group of school administrators gathered to identify student needs based on internal and state mandated assessments. The LCAP was reviewed with the business (i.e.classified) departments in May 2023. During a reclassification event for our emerging bilinguals, the LCAP survey was shared with all participants. All site and program leaders along with teachers were invited to participate via email. The 2023-24 LCAP survey helped gather authentic input to our LCAP goals and action steps. After reviewing all the educational partner feedback and making revisions to the proposal, the school developed the final version of the 2023-24 LCAP. The 2023-24 LCAP was then presented to the Governing Board for their approval in June 2023.

Our decrease in decoding led us to establishing an early literacy focus group with expert teachers to address specific student needs. Regretfully, this was implemented late in the year. Students receiving the additional support did however increase during the targeted intervention. Additionally, because of the focus group, teachers have requested to attend summer professional learning to expand on their knowledge of best practices to support how to teach to reading.

HPCS will continue to learn through professional development and will progress monitor students not at benchmark every two weeks beginning in September.

When asked on the 2021-2022 end of year parent survey, 66% of parents indicated they were very satisfied with the work HPCS has done to establish and sustain an positive relationship between staff, families and students while 30% indicated they were satisfied. While these numbers indicated overall satisfaction, there is room for growth on establishing a greater connection with families as we come out of a pandemic. Increasing opportunities for families to leave their homes and engage with in-person school activities will be paramount to the continued and increased satisfaction as well as provide for additional opportunities to serve student and families social and emotional well-being.

Parents also overwhelmingly indicated (73%) they felt it was important for schools to seek parent input in making decisions for the school. By establishing goals for more frequent school assemblies, school leaders will be given the opportunity to hear and address parents' concerns and input for program improvements. - Keep and Update percentages

Due to the increase in engagement, especially after stringent COVID regulations were lifted we have found the positive benefits of bringing families together alongside our teachers.

Again, we saw some great gains in this area. Based on our data in ELA and Math, HPCS has decided to shift funding from this goal to goal 1 to support student intervention with targeted supports.

Our student population of English learners, students identified as low income, and Foster Youth far exceeds the 55% unduplicated threshold for using our funds schoolwide. The school will expend these funds according to the identified areas of need for our unduplicated pupils. The largest amount of funding is aimed directly at interventions for academic supports for completing credits, which will lead towards successful graduation.

To better serve our at-risk and highly mobile population, the Local Control and Accountability Plan includes the following possible additional actions and services such as, but not limited to:

- Additional services for social-emotional support
- Professional development and curriculum for English learners
- Continuously evolving CTE program designed to promote college and career readiness
- · Early monitoring and interventions for struggling potential graduates

The school implements a personalized learning experience for English learners, low income, Foster Youth, and Special Education students that is strategically integrated with their unique academic and socio-emotional needs. The school has calculated the amount it intends to receive in Supplemental and Concentration funding under the Local Control Funding Formula. These funds are based on the number of English learners, students identified as low income, and Foster Youth. The school's proportional percentage has been calculated and we have demonstrated that we have met the proportional percentage by spending all supplemental and concentration funds allocated, on services for the unduplicated student population, as outlined in the LCAP. The LCAP demonstrates that funds are principally directed to the needs of our unduplicated students.
