




This chart shows the total general purpose revenue New Pacific School Rancho Cordova expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for New Pacific School Rancho Cordova is \$2,527,908, of which \$1,085,516.00 is Local Control Funding Formula (LCFF), \$23,055.00 is other state funds, \$1,411,812.00 is local funds, and \$7525.00 is federal funds. Of the \$1,085,516.00 in LCFF Funds, \$106,642.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



New Pacific School Rancho Cordova will be a K-12 learning community where students are empowered to be self-directed scholars, connected to themselves and others as a whole-child and encouraged to embark on a rigorous, personalized learning plan. It is the school's belief that this best occurs when all levels of the community—students, parents, teachers, staff—collaborate to support whole-child success. This means that the cognitive, emotional, social, and academic growth of our students is the very core of our work. New Pacific School's goals, actions, and measurable outcomes, both schoolwide and for each subgroup of pupils, will address and align with the State Priorities. New Pacific School Rancho Cordova is authorized by the Folsom Cordova Unified School District and will serve TK-5 students in the 2023-2024 school year.

## **Reflections: Successes**

As a newly established charter school, NPS Rancho Cordova currently lacks baseline data to showcase success or progress. The principal, with a background spanning over 20 years in charter schools, has assembled a high-quality, fully credentialed teaching staff amid nationwide teacher shortages.

Preceding the official start of the school year, all staff will undergo training and professional development focusing on school culture, safety, and high-quality instruction. The school's mission will be collaboratively discussed, ensuring alignment and commitment to action goals. Professional curriculum coaches will provide subject-specific training, fostering a cohesive instructional team.

Embracing a Multi-Tiered System of Supports (MTSS), NPS RC New Pacific empowers students to control their own education by focusing on self-esteem and self-efficacy. We support a self-directed, project-based curriculum that cultivates independent motivation to become lifelong learners. Our dedicated wellness teams support students social-emotional learning and student wellbeing. NPS Rancho Cordova is committed to supporting all learners, providing training for staff to address diverse abilities and needs. Differentiation will be implemented for English learners, those with IEPs, requiring interventions, accommodations, or enrichment. Recognizing differences from the California State Standards, instructional staff and administrators will scrutinize data and curriculum to identify and address any gaps through targeted training or support.

## **Reflections: Identified Need**

As a new charter school, we lack baseline data to identify areas for improvement in student performance. The first year will focus on professional development in our curriculum and project-based learning, as well as training in social emotional supports. Administration and leaders will provide training in creating a positive school culture, safety, and robust instructional programs.

# **Engaging Educational Partners**

To inform and engage all stakeholders, NPS Rancho Cordova has created a comprehensive website that provides a full explanation of our educational model.

NPS Rancho Cordova has also hosted both formal and informal parent information meetings throughout the spring. As part of NPS's onboarding process for families, the school provides a copy of the Parent and Student Handbook, which includes school policies and procedures. During every teacher interview, the principal spends focused time discussing school expectations and norms. Teachers are also given opportunities to ask questions and share any concerns. NPS leadership and administration have visited other successfully established charter schools in the nation to learn from their successful practice. Educators received training in SIPPs and were instructed on progress monitoring diagnostics for both English Language Arts (ELA) and Mathematics. Additionally, all teachers and staff engaged in professional development with our social-emotional learning program trainer from Leader in Me. Moreover, the entire staff participated in a two-day verbal de-escalation training conducted by our SELPA. As this is the NPS's inaugural year and year and the LCAP is due before school starts, a presentation of the LCAP to staff and parents was not possible.

Our educational partners have offered valuable feedback and recommendations on key areas including ensuring campus safety, continuous teacher training, comprehensive support for diverse learners, fostering a positive and inclusive school environment, delivering an excellent instructional program, and recruiting high-quality staff.

The primary areas mentioned by stakeholders as a collective are academic intervention and rigor, student social and emotional learning and professional learning for our educators. Each one of these three areas had an impact on the final draft of the LCAP. Specifically, New Pacific School Rancho Cordova added increased staff development in the use of reading assessment and interventions. The assessments will be utilized to identify current reading levels of our scholars and provide information to our teachers for both student learning and the impact of their teaching. Tier 2 and Tier 3 interventions will be used to increase the learning rate for the scholars whose needs are not being met with first instruction. Frequent progress monitoring will be used to measure the impact of the interventions on the scholars. For our social and emotional learning, a focus on the eight habits of highly effective people from our program developed with the Leader in Me model will be the center of our mission to develop community leaders. We have professional learning days planned both before the start of the school year and during the school year for our development of the Leader in Me model of learning.

Future LCAPs will include the results of our scholars who participate in the CAASPP but since this is our first school year, we do not have CA Dashboard data. All students will be assessed regularly using a broad spectrum of formal and informal assessments.

  - This amount is the total of the Planned Percentage of Improved Services column
- 8. Total Estimated Actual Percentage of Improved Services (%)
  - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

• 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
