General Information

Heritage Peak Charter School (HPCS) is a college preparatory public charter school founded in 2005 by the Pacific Charter Institute (PCI), a non-profit 501(c)(3) public benefit corporation. Governed by PCI's Board of Directors, HPCS operates within the Independent Study/Home School model, offering personalized learning for students in grades TK-12.

The school's core principle is that education is most effective when tailored to individual strengths and needs. HPCS collaborates with students, parents, and the community to develop each student's potential. The Independent Study model allows teachers flexibility in tailoring learning paths to meet unique educational goals.

HPCS's vision and mission focus on developing self-motivated individuals in the Sacramento region, aligning with current educational research and the belief that all students can achieve high academic standards.

Vision: Developing self-motivated educated individuals in the Sacramento region who will contribute globally.

Mission: Empowering students to take charge of their education, connecting individual needs to a rigorous learning plan, fostering responsible citizens, critical problem-solvers, and lifelong learners.

The Academic Triangle underscores the interdependence of students, parents/educators, and teachers, emphasizing their roles in supporting student success. HPCS is committed to producing self-motivated students, including those facing challenges, and offers diverse curricular options to match student ability and interests.

Our enrollment is 1126 students with significant student demographics consisting of 13% Special Education, 15% EL (predominantly Spanish and Russian/Ukrainian speakers), 67% Socio-Economically Disadvantaged, and .01% Homeless. The largest groups at HPCS consist of our Hispanic and socio-economically disadvantaged students at 24% and 67% respectively.

HPCS strives for high academic results, using California State Standards-based curriculum and online support programs aligned with Common Core and state-specific standards. Professional development and policies are informed by student data and board reviews to support school-wide learner outcomes.

Accreditation

HPCS is accredited by the Western Association of Schools and Colleges (WASC) through June 30, 2028. Further, HPCS is an active member in California Charter Schools Association, Charter School Development Center and A Plus+.

Reflections: Annual Performance

Heritage Peak Charter School has conducted an in-depth analysis of our student body's academic performance, revealing several critical areas requiring focused attention. Based on data from the California School Dashboard, the following key findings have been identified:

Student Needs Assessment:

Students with disabilities and English Language Learners (ELL) exhibit the most significant academic needs, particularly in English Language Arts (ELA) and Mathematics.

Math proficiency is a notable concern across all student demographics, with ELL and Socioeconomically Disadvantaged (SED) students scoring in the red performance band, indicating urgent attention is required. These needs will be addressed through extra support from an English Learner (EL) Support Teacher who will provide teachers, parents, and/or students with direct intensive instructional support services including research based effective strategies and interventions. There will also be an increase in parent training workshops by the LEA's subject matter experts, and an improved website which will allow parents easier access to teaching and learning resources.

English Language Proficiency:

English Learners are not progressing at a rate commensurate with state benchmarks in English Language Proficiency, necessitating targeted interventions and support structures.

Math emerges as the primary area of concern across all student groups and grade levels, with an overall proficiency rate of only 23%.

There's a concerning decline in math and ELA proficiency as students advance through grade levels, with high school students, notably Grade 11, exhibiting the most pronounced deficit, with only 9% proficiency.

ELA Proficiency:

Grades 3, 4, 5, and 11 demonstrate the lowest proficiency levels in ELA, indicating a need for targeted literacy interventions and support strategies.

Resource Allocation and Equity:

No resource disparities have been identified among subgroups at Heritage Peak Charter School. All students receive equal funding, and additional academic support services are provided through supplemental and federal funds.

Measures are in place to ensure equitable access to educational resources, including technology, internet connectivity via hotspots, and essential school supplies, particularly for homeless, foster youth, and financially disadvantaged students.

In response to these findings, Heritage Peak Charter School is committed to implementing targeted interventions, professional development programs, and collaborative initiatives to address the identified needs comprehensively. Through a concerted effort involving stakeholders, educators, and the wider community, we aim to foster an inclusive learning environment that empowers all students to thrive academically and beyond.

During our meetings with educational partners, we shared the goals of the LCAP, student data, and proposed actions. Feedback included:

Some of the top items were tutoring, math and science classes for middle and high school students, hands-on science learning for younger students, a focus on continued support for early literacy and math, music, theater, art, and field trips

This feedback has led to more specific actions related to increased student support for EL and special education students, see Goal 1, and increased funding for parent/student engagement.

A written reply to the PAC recommendation was sent on May 23, 2024.

Evaluation of the California School Dashboard (Dashboard) data demonstrated a necessity to increase proficiency in English Language Arts (ELA), mathematics, and English language development (ELD). As shown by the data:

45% of students grades 3–8 and 11 met or exceeded the standard in English Language Arts on the Smarter Balanced assessments. However, this proficiency level drops significantly for low-income (LI) students to 32%, and even more so for English learner (EL) students to 14%.

Similarly, only 23% of students across grades 3–8 and 11 met or exceeded the standard in Mathematics on the Smarter Balanced Assessments, with percentages for low-income (LI) students 17% and EL students 10%.

39.6% of English learner students progressed at least one English Learner Progress Indicator (ELPI) level, highlighting a crucial area for improvement.

Action Plan and Metrics for Improvement:
 Heritage Peak plans to enhance ELA and mathematics performance alongside English learner proficiency through strategic interventions that bolster student learning. The progress towards this goal shall be monitored using the following metrics: CAASPP, MAP, DIBELS, mClass, ELPI.

According to the 2023-2024 end-of-year parent survey, % of parents expressed a high level of satisfaction with Heritage Peak Charter School's efforts in fostering positive relationships among staff, families, and students. Additionally, % indicated they were satisfied, indicating an overall positive sentiment. However, these figures underscore the potential for growth in strengthening connections with families, especially in the aftermath of the pandemic.

Enhancing opportunities for families to participate in in-person school activities will be crucial for fostering increased satisfaction and facilitating additional avenues for supporting the social and emotional well-being of both students and families.

Furthermore, a significant majority of parents 90% emphasized the importance of schools actively seeking parental input in decision-making processes. To address this, setting objectives for more frequent school assemblies will provide school leaders with a platform to listen to and address parental concerns and suggestions for enhancing various programs.
