New Pacific Charter is a TK-12 school currently serving a TK-8 learning community where students are empowered to be self-directed scholars, connected to themselves and others as a whole-child and encouraged to embark on a rigorous, personalized learning plan. It is the school's belief that this best occurs when all levels of the community—students, parents, teachers, staff—collaborate to support whole-child success. This means that the cognitive, emotional, social, and academic growth of our students is the very core of our work. New Pacific Charter's goals, actions and measurable outcomes, both schoolwide and for each subgroup of pupils, address and align with the State Priorities. New Pacific Charter Roseville is authorized by Roseville Joint Union High School District and served 154 students in 2023-2024.

During the 2023-2024 academic year, New Pacific Charter Roseville made the following progress in academic performance for both English Language Arts (ELA) and mathematics:

1. ELA and Math Academic Achievement:

2023 CAASPP ELA DFS is -26.8 while the math DFS is -60.4. Because 2022-2023 was the school's first year of operation there was not status change. SED students scored poorer on both ELA (-23.8) and math (-86.1)

Identified Areas for Focus Based on Dashboard Insights:

1. Continued Progress Monitoring and intervention to increase Academic Achievement:

Emphasizing the importance of ongoing assessment and evaluation to ensure sustained academic growth across all grade levels, student groups, and subjects with special efforts focused on SED students.

2. Parent Engagement:

Strengthening partnerships with parents and guardians through enhanced communication and involvement initiatives to support student success both at home and in school.

- 3. Increase support for Math for all students and increased resources and support for EL students.
- 4. Continue to implement and support social emotional learning.

No resource disparities have been identified among subgroups at New Pacific Charter Roseville. All students receive equal funding, and additional academic support services are provided through supplemental and federal funds.

Measures are in place to ensure equitable access to educational resources, including technology, internet connectivity via hotspots, and essential school supplies, particularly for homeless, foster youth, and financially disadvantaged students.

In response to these findings, New Pacific Charter Roseville is committed to implementing targeted interventions, professional development programs, and collaborative initiatives to address the identified needs comprehensively. Through a concerted effort involving stakeholders, educators, and the wider community, we aim to foster an inclusive learning environment that empowers all students to thrive academically and beyond.

During our meetings with educational partners, we shared the goals of the LCAP, student data, and proposed actions. Feedback from our partners included requests for events such as graduation, dances, sports, and potential local school partnerships, as well as additional enrichment activities, greater parent participation as guest teachers or classroom helpers, and a student advisory committee. (Action 2.1). Finally, parents would appreciate improved contact and staff information on the school website, (Action 4.2). This feedback has led to more specific actions related to parent engagement, increased enrichment activities, and planned website improvements. A written reply was sent to the PAC acknowledging their contributions to the LCAP.

Evaluation of the California School Dashboard (Dashboard) data demonstrated a necessity to continue academic growth by continued focus toward K-2 literacy in reading and math, along with interventions for EL, special education, and SED students.

While 43% of students grades 3–5 met or exceeded the standard in English Language Arts on the Smarter Balanced assessments this proficiency level drops significantly for SED students to 33%.

Similarly, only 28% of students across grades 3-5 met or exceeded the standard in Mathematics on the Smarter Balanced Assessments, with percentages for SED students 17%.

Action Plan and Metrics for Improvement:

New Pacific Charter Roseville intends to enhance ELA and mathematics performance for all grade levels and student groups through strategic interventions that bolster student learning. The progress towards this goal shall be monitored using the following metrics: CAASPP, MAP, DIBELS, mClass, and ELPI.

All students will be assessed regularly using a broad spectrum of formal and informal assessments.

According to the 2023-2024 end-of-year parent survey, 84% were satisfied overall, 83% felt informed when making school decisions, 84% believed New Pacific Roseville meets their students' learning needs, and 86% felt the school communicates regularly. However, these figures underscore the potential for growth in strengthening connections with families, especially in the aftermath of the pandemic.

Enhancing opportunities for families to participate in in-person school activities will be crucial for fostering increased satisfaction and facilitating additional avenues for supporting the social and emotional well-being of both students and families.

Furthermore, a significant majority of parents % emphasized the importance of schools actively seeking parental input in decision-making processes. To address this, setting objectives for more frequent school assemblies will provide school leaders with a platform to listen to and address parental concerns and suggestions for enhancing various programs.
